*RELEASE OF LIABILITY

In consideration of my participation and opportunity to use HopHounds, and for other good and valuable consideration, I hereby assume all responsibility for any and all risks of property damage or bodily injury that I, my guests, my dog(s) or my property may sustain while visiting HopHounds. I hereby (1) agree to be solely financially responsible for, and shall indemnify and hold harmless, HopHounds and any of its officer, employees, agents, and related parties (hereinafter referred to as "Releasees") from and against, and shall release, waive, discharge and covenant not to sue Releasees for any losses, liabilities, costs, claims or damages of any kind or nature (including, without limitation, incidental and consequential damages), expenses (including, without limitation, costs of investigation, defense and settlement, and reasonable attorneys' fees), whether or not involving a third-party claim (collectively "Damages") arising, directly or indirectly, out of or related to any loss, damage, injury or death that occurs to property, person or dog, as a result of my participation at HopHounds (including Damages caused in whole or in part by negligence of the Releasees), and (2) knowingly and voluntarily assume any and all risk of harm to property, persons or dogs (including Damages caused in whole or in part by negligence of HopHounds or Staff). I specifically understand that I am releasing, discharging, and waiving any claims or actions, known or unknown, that I may have presently or in the future for the negligent acts on other conduct by the Releasees. HopHounds specifically disclaims all liability and shall not be responsible for any adverse reaction to shampoos or grooming products used in the Wash Station. All Memberships are non-refundable.

PARK RULES

1. The One-Day Pass/Membership Agreement and Release of Liability releases HopHounds from any liability to you, your dog(s), or anybody accompanying you, and applies to all visits to HopHounds facilities for the duration of your Membership. Any false statements are grounds to revoke your Membership.
2. Dogs must be current (up-to-date) on vaccinations including Rabies, DHPP/DHLPPC, and Bordetella/Cird. Dog parents must provide vaccination documentation to HopHounds in order to be granted a One-Day Pass or HopHounds Membership.
3. Puppies must be older than 4 months of age and must show that they are current on puppy vaccinations.
4. Dogs over 1 year old **MUST** be spayed or neutered to enter the play yard. Dogs not spayed or neutered are allowed inside and on the deck.
5. Dogs must be on-leash unless they are in the off-leash yard; in the off-leash yard, dogs must be off-leash.
6. The dog park is for dogs, their parent(s), and those guests who may be accompanying them. Membership is required for the off-leash yard. Only members or day pass holders with dogs and their guests are allowed in the off-leash yard.
7. By entering the yard, you permit HopHounds staff to handle your dog and break up any fights that may occur. HopHounds will utilize Wooferees to help mitigate safety risks; however, each owner is solely responsible for their and their dog's actions and assumes all liability for damages suffered by any person or dog injured by the member or the member's dog(s) while utilizing the dog park. Be sure to check on your dog(s) periodically if you are not in the yard.
8. Members must retain possession of their leashes. HopHounds is not responsible for lost leashes; however, we will do what we can to help you find them.
9. Only flat-buckle collars should be worn by dogs in the off-leash yard. Prong, pinch, choke and electric collars are not allowed in the park.
10. Prior to gaining access to the off-leash yard, you must check in with HopHounds staff and enter the park in a calm manner.
11. At **NO** point may you leave the property without your dog. Doing this may result in revocation of Membership.
12. Rough play among dogs is acceptable as long as it is consensual. Rough play is not accepted if the dogs involved aren't comfortable with the situation. Mounting and excessive barking should be discouraged. If the behavior continues, the dog may need to be fully supervised by the owner or removed from the off-leash area.
13. No smoking or vaping on premises. No food or treats are allowed in the off-leash yard. Food may be consumed on the deck or the inside bar area. Beverages purchased at the bar are permitted in the park, but we ask that you please remain responsible for your drink and the safety of it while the dogs are playing. Outside drinks are **NOT PERMITTED**.
14. HopHounds reserves the right to refuse service to anyone without proof that they are at least 21 years of age.
15. No one under the age of 18 is allowed in the HopHounds facility without adult supervision. For safety reasons, no children under the age of 16 are allowed in the off-leash yard. Children outside the off-leash yard will not be allowed to scream, chase the dogs or pet another person's dog without first getting that person's permission.
16. Members must clean up after their dog(s). All waste must be bagged and disposed of properly in the marked receptacles. Please notify Wooferees after cleanup so disinfectant can be applied.
17. Aggressive behavior will not be tolerated. If aggressive behavior is observed, immediate action will be taken. Wooferees will do whatever is necessary, to prevent the behavior from reoccurring. IF this aggressive behavior persists, we reserve the right to ask for the parent to take the dog for a time-out, or you may be asked to remove your dog(s) from the yard/premises.
18. HopHounds is not responsible for any injury, illness, or damage caused on our premises, and all Members are legally and financially responsible for their dog(s) and guests.
19. Constant dog barking can be disruptive. Please keep your dog's barking under control.
20. HopHounds Brew Pub & Dog Park closes in cases of severe weather or when emergency maintenance is required. Additionally, the Dog Park hours may vary due to special events. In all cases, HopHounds reserves the right to close the facility or amend its hours of operation at any time without notice; however, HopHounds will endeavor to notify its members via our website, social media, and/or email.
21. HopHounds Management and Staff have the right to refuse service to any customer for any reason.
22. Participation at HopHounds is voluntary and at your own risk. We reserve the right to temporarily remove or permanently restrict any person or dog(s) from the premises for behavior that is potentially harmful to our patrons, staff, or other dogs. It is your sole responsibility to ensure the safety of your dog(s), your guests, and yourself. Your Membership may be suspended or revoked at any time if it is found that you have jeopardized the safety of other people or dogs at HopHounds.
